# Prison and rough sleeping

10 per cent of people (465 people) who were sleeping rough and accessed a Specialist Homelessness Service in 2019-20 had recently been in a custodial setting.

Clients with a court appearance in the previous 12 months are 25 times more likely to experience rough sleeping and access a Specialist Homelessness Service than the general population.

Inmates can access up to two days temporary accommodation through Set to Go

## The Reintegration Housing Support Program



DCJ has launched a new program, in partnership with the Community Restorative Centre (CRC), to provide support to people for leaving custody who are at risk of homelessness.


The Reintegration Housing Support Program (RHSP) is a new two-year program which aims to connect people who are leaving custody and at risk of homelessness with specialist support workers who will assist with securing access to suitable accommodation, as well as wrap around psychosocial support.

The RHSP is operating in six locations across NSW, with two CRC support workers based in each of the following DCJ Housing offices:

## Supporting people exiting custody






Each support worker has a case load of 12-15 clients at any one time (excluding one-off service delivery for drop-in clients, shortterm support, referrals and information provision), with the program aiming to support at least 300 clients per annum. Support includes:

- Referral to appropriate housing supports
- Connection with Community Corrections (parole and probation) and Centrelink
- Alcohol or drug support
- Physical and mental health services
- Help obtaining identification, connecting with friends and/or family in the community
- Obtaining emergency items such as clothing, mobile phones and transportation.
