

Research context and approach





Research context and approach

Aim

Options for transforming Australia's social housing system into a **system for socially supported housing pathways**

Context

- Originally: social housing without growth prospects
- Now: social housing's moment in the political sun
- Decades of visions of social housing transformation
- Dominant logics: rationing, straitening

Approach

Projects on:

- Aspirations
- Access
- Support
- Outcomes







- Low-income households have diverse housing aspirations and are conscious that their needs and pathways change over time.
- Social housing is seen both as an ideal tenure and a stepping stone in housing pathways.
- Despite the rising international interest in policy codesign in human services, there is limited experience of it in Australian social housing and housing assistance policy.




- The application process is often deeply unsatisfactory and upsetting. Private rental assistance appears to be more stopgap than diversionary from social housing, and its efficacy is questionable.
- **Support** for persons with complex needs can be delivered in a range of housing tenures, but social housing offers advantages. Case coordination gets results but can place pressure on workers.
- Social housing officers and stakeholders see outcomes reporting as a way of promoting the value of social housing, but the capacity of organisations to conduct evaluations varies.



- 'Housing pathways'
 - Centres subjective meanings of housing and home
 - Against housing 'careers' and 'ladders'
- Person-centred housing assistance strategy
- Data improvements
- Legislative reform (the Housing Acts)



Policy development options: participation and co design





Participation and co-design

- Two levels: system and individual
 - System: review and co-design operational policies, especially private rental assistance and the application process
 - Individual: consider individual housing plans (but not disciplinary)



Policy development options: data and reporting






Data and reporting

- Data for accountability, and for best practice
- Accountability: data improvement plans, especially re private rental assistance, temporary accommodation
- **Best practice**: an 'Australian housing clearinghouse' for sharing information and evaluations, informing co-design



Policy development options: legislative reform





Legislative reform

- Most jurisdictions' housing legislation says little about the operation of social housing and nothing about private rental assistance
- Legal entitlements to housing assistance are weaker than those to social security and disability support
- **Reform** housing legislation to:
 - reflect the range of forms of assistance provided
 - commit to co-design principles
 - enshrine the right to reasonable and necessary housing assistance
